APPROVAL OF ORDINANCE 405 ON THE 2<sup>ND</sup> READING, AN ORDINANCE OF THE TOWN OF HANNA, CARBON COUNTY, WYOMING AMENDING TITLE 17 OF THE HANNA TOWN CODE REGULATING SPECIAL USE PERMIT USES FOR R1 ZONING.

Cm. Sikes moved to approve Ordinance 405 on the 2<sup>nd</sup> reading, An ordinance of the Town of Hanna, Carbon County, Wyoming amending Title 17 of the Hanna town code regulation special use permit uses for R1 Zoning.

APPROVAL OF ORDINANCE 406, ON THE 2<sup>ND</sup> READING AN ORDINANCE OF THE TOWN OF HANNA, CARBON COUNTY, WYOMING AMENDING TITLE 13 OF THE HANNA TOWN CODE, INCREASING THE COST OF WATER AND SEWER TAPS.

Cm. Dys moved to move forward with an ordinance rewrite to all for livestock in town only at the **High School for Educational Purposes and to have the school submit a building permit application for the barn.** Cm. Felix seconded the motion. Motion carried with all present members voting aye.

DISCUSSION ON MOVING FORWARD TO MOVE A CAT 77B HAUL TRUCK TO VETERANS PARK TO DISPLAY AS A MINING MEMORIAL FOR THE TOWN.

Cm. Felix moved to approve moving forward to move a **CAT 77b Haul Truck to Veterans Park to display as a mining Memorial for the Town.** Cm. Sikes seconded the motion. Motion carried with all present members voting aye.
