**OLD BUSINESS:**

APPROVAL OF ORDINANCE 407 ON THE 2<sup>ND</sup> READING, AN ORDINANCE OF THE TOWN OF HANNA, CARBON COUNTY, WYOMING AMENDING TITLE 17 OF THE HANNA TOWN CODE REGULATING THE KEEPING OF ANIMALS WITHIN THE CORPORATE LIMITS OF THE TOWN OF HANNA AND THE KEEPING OF ANIMALS FOR EDUCATIONAL PURPOSES

Cm. Sikes **moved to approve Ordinance 407 on the 2<sup>nd</sup> reading, an ordinance of the Town of Hanna, Carbon County, Wyoming amending Title 17 of the Hanna Town code regulating the keeping of animals within the corporate limits of the Town of Hanna and the keeping of animals for educational purposes, with a change to make it 10 animals allowed per school year no matter the species.** Cm. Felix seconded the motion. Motion carried with all present members voting aye.

**NEW BUSINESS:**

OPEN OF BIDS FOR TOWN HALL ROOF REPLACEMENT;

Two (2) bids were received to replace the Town Hall Roof with a pitched metal roof and gutters. 1<sup>st</sup> Bid came from Davidson Construction LLC., in the amount of \$235,000.00. 2<sup>nd</sup> bid from High Road Roofing in the amount of \$115,948.64.

Cm. Sikes **moved to approve the bid submitted by High Road Roofing in the amount of \$115,948.64 for the Town Hall pitched metal roof.** Cm. Dys seconded the motion. Motion carried with all present members voting aye.

APPROVAL OF PROPOSAL TO WINTERIZE THE PLUMBING FOR THE HANNA RECREATION CENTER.

Cm. Dys **moved to postpone proposal to see if we could get more proposals.** Cm. Million seconded the motion. Motion carried with all present members voting aye.
